

Board of Trustees Meeting Gaines Technology Center Conference Room November 6, 2014

Members present: Sue Gibson, Dr. Paul Baltz, Doug Cox, John Jackson, Ray Noel, Leo Baltz, Ruth Ann Ellis and Dr. Eric Turner. Guests present: Angie Caldwell, Dr. Roger Johnson, Martha Nelson and Karen Liebhaber. Vickie French was present to record the minutes of the meeting.

APPROVAL OF MINUTES

Motion by John Jackson to approve the minutes of the August 28, 2014 meeting as presented. Motion seconded by Ray Noel. Unanimous.

PRESIDENT'S REPORT

Health Science Complex

Dr. Eric Turner stated the final pour for the concrete pad was completed last Thursday and the steel is arriving. Columns should begin to be erected today and the trusses are here for the second floor. The project is still within budget and on target for completion.

Fire Tower

A ceremonial demolishing of the fire tower was held on October 16th. The College is awaiting approval on the Method of Financing before proceeding; this meeting will be convened on November 17th. Because no funds will be borrowed to complete the project, approval from the ADHE Coordinating Board are unnecessary, so the project approvals should be streamlined.

Barracks

A meeting was held in September with staff members from Senator Boozman's office regarding possible funding sources for the LETA barracks project. Dr. Turner and Steve Shults both felt the primary outcome of the meeting was to think more broadly than only barracks for LETA; serving the broader community and region was paramount. In this vein, Turner and Shults began investigating what other community colleges are doing in terms of programming for emergency preparedness/first responders.

In a coordinated effort between Alan Haskins of Fire Science and Steve Shults, plans are to visit 2-3 community college campuses in Florida and Georgia to obtain first hand perspectives of facilities and programming related to the bundling of the law enforcement and fire science programs together and marketing them as an emergency preparedness training center. Dr. Turner updated the board on the possibility of such an endeavor and the potential for such a program and how it might work over the long term and how this informs the strategic planning to commence next year.
