Simply passing this program does NOT certify you as a Firefighter in the State of Arkansas. Each Student MUST set for and PASS the Arkansas Fire Academy Firefighter 1 and 2 tests to become certified. The minimum passing score is a 70%. Each student must also pass the physical agility test or FEATS Test and the assigned JPR tests (hands on) sections as well. Each student must meet and pass the appropriate prerequisites to set for these tests as well which consist of CPR, EMR or EMT, Haz-Mat Awareness and Operations and the Arkansas Forestry Wildlands Firefighting course, all of which are in the Firefighter 1 and 2 courses here at BRTC. This all means you can pass the class, but still not be certified.

As mandated by Act 472 of 2007, I have been informed of the Arkansas Course Transfer System, and how to determine which courses will transfer to other Arkansas public institutions.

ACTS Transfer Courses

Courses notated in the degree plan with the “ ~ “ symbol are considered ACTS courses.
